featuring breakouts and analysis accompanied by an article in which leading attorneys discuss their construction clients' most pressing business concerns.

To determine the ranking, CE asked hundreds of U.S. law firms with construction practices to complete a survey. Data collected included: 1) 2023 revenues from the firm's construction practice; 2) number of attorneys in the firm's construction practice; 3) percentage of firm's total revenues derived from its construction practice; 4) number of states in which the firm is licensed to practice; 5) year in which the construction practice was established; and 6) the number of Architecture, Engineering and Construction clients served during fiscal year 2023. The ranking was determined by an algorithm that weighted these factors in descending order of importance.
