# **Careful Questioning Exposes 'Expert' in Malpractice Trial**

A client, an anesthesiologist, faced charges of medical malpractice and wrongful death. The plaintiff hired an expert who had testified in hundreds of cases. Jordan reviewed thousands of pages of deposition and trial testimony from those cases and found prior testimony in which the expert contradicted his opinion in the pending litigation.
