

# **Savvy Negotiations Avert Picketing at Construction Site**

A hospitality client was expanding its operations by building a major addition to its existing footprint. The work was performed by a number of different union contractors whose efforts all had to be coordinated to ensure completion of the project on schedule. Time was of the essence, as a significant portion of the client's operations was shut down due to the expansion.

One of the on-site unions threatened picketing, which would have brought the entire construction project to an abrupt stop. Millions of dollars was at stake. However, Terry and the Husch Blackwell team successfully negotiated a resolution in short order, without any work interruption.
