verdict in under three hours); investigating and filing a landmark civil rights suit against the Chicago Cubs, alleging violations of the Americans with Disabilities Act at Wrigley Field (which resulted in a consent decree providing unprecedented access for wheelchair users at the stadium); and defending the U.S. Department of Education in a high-profile case brought by the Chicago Teachers Union.
